The enormous stores of electronic information being created by organizations present themselves increasingly as critical organizational assets, sources of risk, and management challenges. Movement of organizations toward the multi-tenant server-based "public cloud" exacerbates the need for the involvement of counsel in structuring relationships, due diligence and oversight. Security (and some privacy) issues have been the most often noted, but e-discovery and records & information management issues may have much greater consequences for many organizations. In addition, technologies that make corporate information stores ever-more-accessible often work on virtual information stores as well, risk opening "Pandora's Box" without clear and careful guidance from records management and counsel. We will offer a review of risks and opportunities for records managers in the management of organizational information as movement into the public cloud is contemplated, including concrete solution sets for dealing with diligence, contractual issues and disputes. We will include recommendations in the areas of protection of corporate confidential information, intellectual property and trade secrets; the security and privacy of information; records and document management; and electronic discovery.
